The Management Team bears the responsibility for establishing, maintaining and implementing the OH&S system, and setting OH&S objectives in order to plan and monitor delivery. The OH&S policy will be the Managing Director's ultimate responsibility to ensure the management of health and safety is adequately resourced and maintained.

Horstman Defence Systems Limited is committed to:

- Complying with its legal duties, codes of practise and other agreed conditions of operation in order to provide a safe and healthy working environment for its employees and other people affected by the company's activities. Where possible and practicable the company will exceed the minimum requirements of applicable legislation.
- Providing a positive safety culture in which every employee, contractor and visitor feels free to speak up about non-conformances, undesirable or unsafe situations or any other OH&S related issue;
- Identifying hazards, risk assessment and implementing control measures to eliminate or reduce risk to health and safety of employees, visitors and third parties by our activities;
- Providing all employees, contractors and visitors with relevant information, operational controls and regular training on OH&S requirements to enable them to conduct their activities safely;
- Consulting and collaborating with employees and/or their representatives and other interested parties on OH&S matters;
- Implementing a Plan-Do-Check-Act systematic approach to ensure continual improvement of OH&S performance;
- Meeting or exceeding all applicable health and safety laws and regulations in relation to the activities the company carry out.
- Having health and safety as its top priority for all employees.

Our policy cannot be implemented without the full co-operation and support of all Horstman Defence Systems Limited employees and subcontractors who are expected to play a full and active part in putting this policy into practice. Employees are encouraged to raise any concerns and suggestions for improvements in the safe working arrangements at all levels within the Company. Safe working is a team effort with everyone playing a vital part.
